

Raisin Charter Township Election Commission  
Resolution to Divide Election Precincts  
Resolution No. 2017-032117

At a special meeting of the Election Commission of the Raisin Charter Township, Lenawee County, Michigan, held at Raisin Township Office Board Room on the 21<sup>st</sup> day of March, 2017 at 9:00 a.m., Eastern Standard Time:

The following resolution was offered by Hawkins supported by Johnson.

WHEREAS, Section 661 of the Michigan Election Law, as amended (MCL 168.661), provides for township Election Commissions to divide, rearrange or temporarily consolidate election precincts; and

WHEREAS, the Election Commission of the Raisin Charter Township has determined that dividing Precincts 1 and 2 is appropriate in order to comply with the statutory limit of 2,999 registered voters, pursuant to MCL 168.661(1). Precincts 1 and 2 consist of the following boundaries:

Precinct 1: South side of Russell/Schull Road from Green Hwy to Hendershot Hwy, west side of Hendershot Hwy from Schull Road to Academy Road, north side of Academy Road from Hendershot to M-52, east side of M-52 from Academy Road to Sutton Road, south side of Sutton Road from M-52 to Green Hwy, and east side of Green Hwy from Sutton Road to Russell Road.

Precinct 2: east side of M-52 from Sutton to Russell Road, south side of Russell Road from M-52 to Green Hwy, west side of Green Hwy from Russell Road to Sutton Road, and north side of Sutton Road from M-52 to Green Hwy.

NOW, THEREFORE, BE IT RESOLVED that the Election Commission of the Charter Township of Raisin hereby directs the Township Clerk to divide Precincts 1 and 2 as described above into the following election precincts:

Precinct 1, the boundaries of which shall be the south side of Schull Road from Rogers Hwy to Hendershot Hwy, west side of Hendershot Hwy from Schull Road to Academy Road, north side of Academy Road from Hendershot Hwy to M-52, east side of M-52 from Academy Road to Sutton Road, south side of Sutton Road from M-52 to Rogers Hwy, and east side of Rogers Hwy from Sutton to Schull Road;

Precinct 2, the boundaries of which shall be the east side of M-52 from Sutton to Russell Road, south side of Russell Road from M-52 to Occidental Hwy, west side of Occidental Hwy from Russell Road to Sutton Road and north side of Sutton Road from Occidental Hwy to M-52; and

Precinct 3, the boundaries of which shall be the south side of Russell Road from Occidental Hwy to Rogers Hwy, west side of Rogers Hwy from Russell Road to Sutton Road, north side of Sutton Road from Rogers Hwy to Occidental Hwy, and east side of Occidental Hwy from Sutton Road to Russell Road.


