Presentation by Schultz regarding various options for Precinct Polling Locations. After discussion it was the consensus by the board that in the short-term the Raisin Community Center would be the best location for all three (3) precincts.

Motion Hawkins, support Schultz to make physical changes including a new exit door, sidewalk, and wi-fi at Raisin Community Center to accommodate 3 precincts. Motion failed with 2 yes and 4 no votes.

8.3 Election Commission – Resolution for Polling Location (all precincts)

Motion Hawkins, support Johnson that the board approve Resolution #2017-061217 to establish Raisin Community Center as the polling location for Precinct 1, 2, & 3 and location of Absent Voter Counting Board at Raisin Township Hall.

8.4 Disposition of Surplus Equipment – Police vehicles, Aircraft Rescue Crash Truck

Discussion on the sale of 2001 Ford Expedition (Kelly Blue Book value of \$1,735), 2009 Crown Victoria (KBB value of \$5,787), and 2009 Chevrolet Tahoe (KBB value of \$7,806). Prices are based on a vehicle in fair condition.

Motion Mead, support McDermott to have Witt sell the 3 surplus police vehicles at or near the vehicle's fair condition value. M/C, all

It was the consensus of the board to reduce the price of the Aircraft Rescue Crash Truck to \$15,000 obo.

8.5 CLEMIS - Approval for Supervisor to Sign Interlocal Agreement

The Police Department has been using the CLEMIS software since January and they are very pleased with the information and data sharing that is possible with this system. Although the cost is a little more than our old software, the ability to work with other jurisdictions is very valuable.

8.6 LCRC 2017 Road Contracts - Additional Projects / Budget Amendment

Witt presented information regarding additional road projects that the board should consider. The Gady Road project was changed. The new project is estimate #3466 for the amount of \$27,563.87. Raisin Center Highway project was added. This project is estimate #3453 for the amount of \$57,223.79. These additional projects would take us a little over the amount committed for road repair for 2017. We have saved money in several areas so we will be able to financially accommodate this additional expense in our budget or use the Road Fund Balance.

Motion Hawkins, support Johnson to approve both additional road projects on Gady Road (LCRC estimate #3466) and Raisin Center Hwy (LCRC estimate #3456) for 2017. M/C, all
