

ATTENTION RAISIN CHARTER TOWNSHIP RESIDENTS

Raisin Charter Township has adopted Ordinance No. 2018-100. It is an ordinance to provide a title for the ordinance, to define words; to prohibit marihuana establishments within the boundaries of Charter Township of Raisin pursuant to Initiated Law I of 2018, MCL 333.27951, *et seq.*, as may be amended; to provide for severability; to repeal all ordinances or parts of ordinances in conflict therewith; and to provide an effective date.

RAISIN CHARTER TOWNSHIP ORDAINS:

1)This ordinance shall be known as and may be cited as the Charter Township of Raisin Prohibition of Marihuana Establishments Ordinance.

2)Words used herein shall have the definitions as provided for in Initiated Law 1 of 2018, MCL 333.27951 *et seq.*, as may be amended.

3)The Charter Township of Raisin hereby prohibits all marihuana establishments within the boundaries of the Township pursuant to Initiated Law 1 of 2018, MCL 333.27951 *et seq.*, as may be amended.

PENALTY: Any person who disobeys neglects or refuses to comply with any provision of this ordinance or who causes allows or consents to any of the same shall be deemed to be responsible for the violation of this ordinance. A violation of this ordinance is deemed to be a nuisance per se. A violation of this ordinance is a municipal civil infraction, for which the fines shall not be less that \$100 or more than \$500, in the discretion of the Court. The foregoing sanctions shall be in addition to the rights of the Township to proceed at law or equity with other appropriate and proper remedies. Additionally, the violator shall pay costs which may include all expenses, and direct and indirect, which the Township incurs in connection with the municipal civil infraction. Each day during which any violation continues shall be deemed a separate offense. The Township may seek injunctive relief against persons alleged to be in violation of this ordinance, and such other relief as may be provided by law.

This ordinance shall be administered and enforced by the Ordinance Enforcement Offices of the Township or by such other person(s) as designated by the Township Board.

SEVERALBILITY: The provisions of this ordinance are hereby declared to be severable. If any clause, sentence, word, section or provision is hereafter declared void or unenforceable for any reason by a court of competent jurisdiction, it shall not affect the remainder of such ordinance which shall continue in full force and effect.

EFFECTIVE DATE: This Ordinance shall be become effective fifteen (15) days after its publication following final adoption or as required by law.

REPEAL: All Ordinances or parts of Ordinances in conflict with this ordinance are hereby repealed.
